Application of product:

Simat artificial aggregate of ferro silico manganese slag is generated as the by-product of ferro silico manganese (FeSiMn) production. After air solidifying and cooling, the slag is excavated, crushed and sieved.

The Simat artificial aggregate fractions are used as protective layers of drainage systems and engineering networks; coarse backfill material; recultivation and ground completion; spreadings for winter road maintenance; construction of bulk country roads and forest roads; for clinker production in cement industry and for mechanical sand surfacing; landscaping, filling, backfilling, packs. Product **does not comply** with the requirements of the STN EN 12620 + A1: 2008 and STN EN 13242 + A1: 2008.

Products shall comply with the declared characteristics and with all of the technical performances listed in the Technical Data Sheet No. TL-005-SK (effective from February 24, 2025) and in the Product Safety Data Sheet No. KBU-005-SK (effective from March 10, 2025).

Products shall comply with the requirements of the Regulation (EC) No. 1907/2006 of the European Parliament and of the Council as amended. Hygiene and health aspects, means of storage and transport are all described in the Technical Data Sheet No. TL-005-SK and Product Safety Data Sheet No. KBU-005-SK.
